Class Information

1. No Registration Fee required for Summer Workshops. Fall registration is July 1 – August 31, 2010 and open to the public on a first-come first-serve basis. Fall classes will start on September 8, 2010.
2. Rates: 2-hour workshops - \$26 (Supplies are not included). Supply list given at registration upon request.
3. Summer Workshops will be filled on a first-come first-served basis. Class size for workshops is 4-8 people. Any date or time slot with less than four people enrolled will be canceled from the schedule. If necessary, those dates or times canceled will be announced, by telephone, no later than June 20, 2010. Proper credit will be given if the student cannot switch to a different open summer workshop, due to a workshop cancellation.
4. **All money** owed for selected summer workshops is **due at time of registration**. Please make checks payable to Lisa G. Bailey. There will be a \$25 fee for all returned/bounced checks.
5. There will be **NO REFUNDS** for any reason except the workshops that I cancel due to low enrollment. If a student is absent, they may take a make-up class but only during the remaining available summer workshops which have less than 8 students registered.
